c)	Quality of research	Dr. G.C. Mishra, Chairman of the University Research Advisory committee briefed about the research at IAR. He commented that Research at IAR is good and progressing well. There is a need to make more applications for research grants.		

d) UGC recognition

Prof. Guna Magesan, Vice Chancellor has briefed the visit of the UGC at the University and updated the UGC report. The University has to submit compliance report on the suggestions by the UGC committee. The final recommendations by the UGC will be available thereafter. Meanwhile University can award the degree.

Mr. Upendra Puri, Chairperson of the committee has suggested that find some person from previous UGC committees who can assist the University to rectify the deficiencies raised by the UGC.

Dr. G.C. Mishra has suggested that UGC recognition is important at National level especially to secure government job or admission at another Government University. Anyhow UGC recognition is required.

e) Salary Structure

The University salary structure was discussed. The University should consider implementing 6th pay Commission for faculty. Dr. G.C. Mishra suggests that salary should be increased by 10%.

An increase of about 10% average in salary increase may be considered including inflation, annual increase. Increase in salary will vary as per performance.

Prof. Gautam Sen suggests that the university could promote additional task based compensation to the faculty.

Mr. Upendra Puri, suggested that University should put in place mechanism to promote Consultancy by the faculty. Policy to promote consultancy should be made.

Dr. Pathak, Dean, presented the current overview of the research at the University.

The Dean updated the committee on the limitations and reduction in research funding across the globe. The current emphasis for grants is on translational research.

Mr. Upendra Puri pointed out limited research grants and suggested improving the research grant status at the university.

University should explore research grant from international agencies.
