**Admission procedure and Merit Criteria for Management quota seats for B.Tech. program, year 2023-24**

Applicant needs to fill the application form available on website [www.iar.ac.in](http://www.iar.ac.in) and will have to upload necessary documents of 12<sup>th</sup> standard, Score card of Gujcet 2023 and/or JEE Main examination 2023.

**Procedure to prepare the Merit list:**

A candidate shall have passed H.Sc. (10+2) with minimum 45% marks (40% for SC/ST/SEBC/EWS) of theory (or theory and practical) marks of Physics, Mathematics or Biology (for Biotechnology program) as compulsory subjects with (Chemistry or Technical vocational subject) from a authorized board.

50% Weightage of 12<sup>th</sup> standard percentile + 50% Weightage to Gujcet 2023 Percentile  
(theory and practical marks in Physics, Mathematics/Biology, and Chemistry/vocational/technical course)

or

50% Weightage of 12<sup>th</sup> standard percentile + 50% Weightage to JEE Main 2023 Percentile  
(theory and practical marks in Physics, Mathematic/Biology, and Chemistry/vocational/technical course)

The Management Seats will be filled, by the management of the Department of Engineering and Physical Sciences, Institute of Advanced Research, Gandhinagar based on the *inter-se* merit list of the candidates whose names appears in the merit list prepared by the Admission Committee:

Merit list will be prepared on common inter-se merit list in the following order and guidelines issued by Admission Committee from time to time:

- I. the names of the candidates whose name appears in the merit list of the Admission Committee;
- II. the names of candidates who have passed qualifying examination from Gujarat State and shall have appeared in GUJCET examination for the year 2023
- III. the names of the candidates who have passed the qualifying examination from outside the Gujarat State and have appeared in GUJCET conducted in academic year 2023.
- IV. after allotting the seats to the candidates mentioned in sub-clauses (i) to (iii) above, University shall fill seats from the candidates who have passed diploma engineering or degree science course and grant the admission on merit. The merit list shall be prepared

on the basis of marks obtained in final year. Such candidate shall be eligible for admission in the first year of engineering or technology courses.

- V. after allotting the seats to candidates mentioned in sub-clauses (i) to (iv) above, the institute shall fill seats from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rules from any authorized board all over the India and Score of JEE Mains 2023 examination on the condition that candidate must have registered with ACPC for the year 2023.
